Official Rules

NO PURCHASE NECESSARY TO PARTICIPATE IN THE IFF “APPLE AIRPODS PRO®” Giveaway Sweepstakes

Eligibility: The IFF “APPLE AIRPODS PRO®” Giveaway Sweepstakes (or the “Sweepstakes”) is not open to the general public. The Sweepstakes runs from 9:00pm on July 13, 2021 to 12:00am on July 14, 2021 (“Sweepstakes Period”).

Eligibility: In order to register, you must be at least 21 years of age to participate in the Sweepstakes, who is a grain processing customer of IFF and must be a registered attendee or exhibitor of the 2021 Fuel Ethanol Workshop (FEW).
